Class 1 Member \$1500 Annual Dues Voting Member

An organization with at least 200 separate and individual residential connections or commercial equivalent.

Class 2 Member \$750 Annual Dues Voting Member

An organization with less than 200 separate and individual connections or commercial equivalent or an organization with over 200 separate and individual connections that are fully built out.

Associate Member \$375 Annual Dues Non-Voting Member

Any firm, corporation, political entity, or subdivision not eligible to be a voting member but desiring to support the Association.

Supporting Individual \$50 Annual Dues Non-Voting Member

Any individual interested party desiring to support the Association.

*Class 1 & Class 2 Membership is open to municipalities, state political subdivisions, tribal government or tribal government affiliated entities, and nonprofit corporations or cooperatives that operate a water distribution system. Associate and Individual Memberships are open to organizations and individuals interested in supporting water for western South Dakota
